




PERSONAL PROTECTIVE EQUIPMENT (PPE)

July 2024

Total participants: 115 in Illinois, Indiana, Missouri & Florida

Demographics:

The largest number of respondents (34%) had between 101-300 employees and over 43% were manufacturers.




Many respondents operate in multiple states or even nationally. However, the largest number of respondents **(41) have locations in Missouri**.

20% of respondents have PPE safety shoe/safety glasses programs that apply to **all employees** while **42**% have PPE safety shoe/safety glasses programs that apply to **specific positions that require regular safety-sensitive work. 37**% of respondents **do not have** a safety shoe/safety glasses program.


SAFETY SHOES:

- 68% of respondents provide employees with safety shoe reimbursement annually.
- 72% of respondents provide eligibility for safety shoe reimbursement on the first day of employment.
- **85**% of respondents do not distinguish pay eligibility for safety shoes based on categories of employees such as exempt/non-exempt. Those that do make that distinction do so for the following reasons:
 - Only covers union employees
 - Office, 1 pair each year, production 2x per year.
 - Only applicable to shop and mobile mechanics
 - o Hourly service and parts have a schedule of increases
 - Usually different jobs so different pay
 - Operations v. Office Staff. Office staff that regularly needs to be in Operations areas also receives this benefit.
 - Exempt employees are immediately eligible for reimbursement, but nonexempt need to wait 90 days to be reimbursed.
- 84% of respondents provide a flat dollar amount for reimbursement.


Average Percent Paid by the Organization for Safety Shoes

73% of respondents reimburse the benefit allowance directly to the employee.


SAFETY GLASSES:

- **36**% of respondents provide employees with safety glasses reimbursement **annually. (34**% **do not** have a safety glasses reimbursement program.)
- While 36% of respondents provide all employees with the safety glasses reimbursement benefit, 47% reimburse only for specific safety-sensitive positions.
- 63% of respondents provide eligibility for safety glasses reimbursement on the first day of employment.
- 94% of respondents do not distinguish pay eligibility for safety glasses based on categories of
 employees such as exempt/non-exempt. Those that do make that distinction do so for the following
 reasons:
 - Only covers union employees
 - Only applicable to shop and mobile mechanics
 - Hourly service and parts have a schedule of increases
 - Operations v. Office Staff. Office staff that regularly needs to be in Operations areas also receives this benefit.
- 65% of respondents provide a flat dollar amount for reimbursement.

Average Percent Paid by the Organization for Prescription Safety Glasses




Highest Benefit Reimbursement Paid by the Company



OTHER PERSONAL PROTECTIVE EQUIPMENT PROVIDED

- 87% of respondents distribute PPE to employees as needed.
- 91% of respondents provide training to employees on the proper use of PPE.
- 56% of respondents use an internal procurement team to source PPE while 49% use external suppliers. (Multople responses were permitted. 4% used government programs and 9% used other sources.)



26% of respondents issue and then collect company-provided PPE back from employees. This includes:

- Safety vest
- Collected back when damaged/expired/requires replacement
- Boots in good condition are collected if an employee leaves the company.
- PPE is collected back when it is time for PPE to be replaced
- Rubber gloves and sleeves must be tested every 6 months to 1 year, hot sticks are the same
- Harnesses
- Respirators are collected back from those who are required to wear/keep/maintain as part of their job.
- Uniforms are issued and collected at the end of a work assignment
- Collect safety goggles from visitors that tour plant
- Time of termination (PPE and uniforms)
- Uniforms are issued and collected when the employee requires a replacement or upon termination.
